

West Lothian Leisure 2017 Gender Pay Gap Report

West Lothian Leisure (WLL) was established on 1st February 1998. WLL is a company limited by guarantee registered in Scotland with registered number SC 543017 and a Scottish Charity registered number SC027470. Our Registered Office is at Xcite Bathgate, Balbardie Park, Torphichen Road, Bathgate, West Lothian, EH48 4LA.

The Gender Pay Gap data supplied is correct for all employees in post with West Lothian Leisure on 5 April 2017.

On that date there were 420 relevant and full-pay relevant employees, 172 (41%) males and 248 females (59%). A higher proportion of females being employed in 3 out of 4 pay bands A, B and D. 58.5% of employees in the upper quartile being female.

The figures set out below have been calculated using the standard calculations used in the Equality Act 2010 (Gender Pay Gap Information) Regulations 2017.

The table above shows West Lothian Leisure's mean and median gender pay gap based on hourly rates of pay.

There were no bonuses paid to any staff in reporting period.

West Lothian Leisure's mean pay gap of -13.6% shows that the mean female hourly rate is higher than the mean male hourly rate. The mean male hourly rate is £12.98 and the mean female hourly rate is £14.74.

At -13.6% the mean gender pay gap for West Lothian Leisure is significantly below the figure for organisations in the same sector, the same industry, organisations with similar turnover and organisations that have a similar number of employees.

West Lothian Leisure's median pay gap of 5.9% shows that the median male hourly rate is higher than the median female hourly rate. The median female hourly rate is £8.55 and the mean male hourly rate is £9.09.

At 5.9% the median gender pay gap for West Lothian Leisure is significantly below the figure for organisations in the same sector, the same industry, organisations with similar turnover and organisations that have a similar number of employees.

Pay Quartiles by Gender

The table above sets out the gender distribution at West Lothian Leisure across four equally sized quartiles.

West Lothian Leisure is committed to the promotion of equality of opportunity in its employment practices. West Lothian Leisure's gender pay gap compares favourably to national statistics but it is committed to monitoring and reducing the gap wherever possible, whilst also recognising that it has no direct control over the gender of applicants for particular job types or an individual's career choices.
